ABOUT THE CONFRENCE

The earth system is witnessing unprecedented population pressure, climate change, invasive species, overutilization of natural resources, pollution and so on which have potential to alter entire ecosystem. Industrialization and post-industrialization societies have been using natural resources much more rapidly than they are being regenerated. The concept of resource efficiency is itself rooted in the paradigm of neoclassical economics-efficient utilization of resources; economic scarcity of resources measured in costs; substitution of scarce resources with alternate technology. Amid deepening debate over the multiple narratives, the focus is on maximising economic output with a given resource input increasing resource productivity, alternatively on minimising resource input with a given economic output with a decreasing resource intensity; or sometimes both. The concept of Eco-efficiency coined by the World Business Council for sustainable development is for the entire humanity. It is defined as delivery of competitively priced goods and services that satisfy human needs and bring quality of life while progressively reducing environmental impacts of goods and resource intensity throughout the entire life cycle to a level at least in line with the Earth's estimated carrying capacity. Thus, out of 17 Sustainable Development Goals, 12 goals are dealing with efficient use of natural resources.

Global environmental and social impact of resource use is difficult to measure. It is particularly difficult to measure long-term impact as well as take into account substitution effects. Therefore, it requires a proper academic debate whether resource efficiency will make economies or ecosystems more resilient or how trade with underdeveloped countries will be affected if developed countries become more resource efficient. Now, the original debate on limits to growth and resource scarcity, these issues are back on the global agenda, European countries and institutions particularly. At the political level there is an increasing recognition that economies are fundamentally dependent on the capacity of the environment to support and generate preconditions for human and societal development. Thus, India and European Union has to pursue various strategies of efficient resource use and stewardship with target of keeping negative social consequences within planetary boundary. The EU is a major trade partner and economic linkages are further deepening. India has been pursuing economic reforms, consequently business climate has improved. India and the EU have increased their political interactions which would positively contribute to the strategic partnership. India and the EU are crucial partners in promoting sustainable development. This is possible when both the region participate in knowledge and technology transfers promoting resource use efficiency and stewardship. This national conference is organized with an aim to bring research scholar, national scientists, social scientists, local academia, policy makers and practitioners to analyze regional and global trends in process of globalization and sustainable development. The primary objective of the conference is to enhance understanding about the region and politics surrounding it. Finally, it will explore multiple dimensions of India-EU cooperation on natural resource management and resource efficiency in context of globalization for just sustainable earth
